**SUPPLEMENTAL DECLARATION TO THE
DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS
FOR RIVER DELL TOWNES**

THIS SUPPLEMENTAL DECLARATION is made as of the date set forth below by DWF Development, Inc. ("Declarant" and "Owner").

WHEREAS, Declarant has heretofore recorded that certain Declaration of Covenants, Conditions and Restrictions for River Dell Townes in Deed Book 3263, Page 39, as supplemented in Book 3269, Page 201 in the office of Register of Deeds, Johnston County, North Carolina, as it may be amended and supplemented from time to time (the "Declaration"); and

WHEREAS, pursuant to Article 9 of the Declaration, the Declarant may unilaterally subject to the Declaration the additional property described on Exhibit "B" thereof by recording a supplemental Declaration pursuant to the terms of the Declaration; and

WHEREAS, the property described on Exhibit "A" hereto is owned by Owner; and

WHEREAS, the Declarant and Owner desire to annex and submit the property described on Exhibit "A" hereof to the Declaration;

NOW, THEREFORE, pursuant to the powers retained by Declarant under the Declaration, Declarant hereby annexes and submits the property described on Exhibit "A" to the Declaration. Such property shall be sold, transferred, used, conveyed, occupied, and mortgaged or otherwise encumbered pursuant to the provisions of the Declaration, which shall run with the title to such property and shall be binding upon all persons having any right, title, or any interest in such property, their respective heirs, legal representatives, successors, successors-in-title, and assigns.

Owner executed this document to consent to the annexation of Owner's property as described in Exhibit "A" attached hereto and incorporated herein by reference.

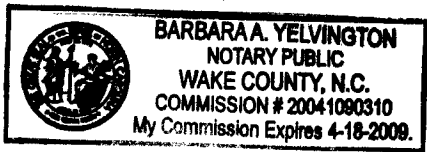
