THIS THIRD AMENDMENT TO DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS is made this 4th day of June, 2013, by DWF Development, Inc. a North Carolina corporation, and Rebecca D. Flowers, an individual, hereinafter jointly referred to as "Declarant".

WITNESSETH:

WHEREAS, Declarant executed a Delaration of Covenants, Conditions and Restrictions for the Village @ Flowers Plantation which is recorded in Book 3233, page 495, Johnston County Registry (the "Declaration"); and

WHEREAS, Declarant recorded the First Amendment to the Declaration in Book 3362, page 113, Johnston County Registry; and

WHEREAS, Declarant recorded the Second Amendment to the Declaration in Book 3943, page 239, Johnston County Registry; and

WHEREAS, Declarant has filed numerous Supplemental Declarations that annex various sections of the Village @ Flowers Plantation which make said sections subject to the Declaration; and

WHEREAS, pursuant to the terms of Section 17.1 of the Declaration, Declarant may unilaterally amend the Declaration for any purpose so long as the Declarant owns any of the Village Property, provided the amendment has no material adverse effect upon any right of any owner; and

WHEREAS, the Declarant owns a portion of the Village Property and this amendment does not have a material adverse effect upon any right of any owner.

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged by all parties hereto, the Declaration is hereby amended as follows:

- 1. Under Exhibit "C", Initial Restrictions and Rules, Paragraph 1, Section (r) is hereby deleted in its entirety and shall be replaced by the following provision:
 - (r) The use or operation of all-terrain vehicles, including, but not limited to, three-wheelers, four-wheelers (except that electric golf carts are allowed subject to the restrictions herein), dirt bikes and go-carts. Operation of electric or battery powered vehicles, golf carts and other similar vehicles (said vehicles may be subject to review by the Association, in which case the vehicles may be prohibited from operation within the property covenanted herein), must be by a licensed driver, 16 years of age or older, and only on the private streets. Golf carts are prohibited on the pedestrian sidewalks and walking trails. Skateboards, scooters, roller blades and other similar transportation devices, whether powered or not, are prohibited from operation on the streets, pedestrian sidewalks and walking trails. Bicycles are <u>not</u> prohibited from operation on the streets but are prohibited from operation on the pedestrian sidewalks and walking trails. Any vehicle not described herein may be subject to review by the Association, in which case the vehicles may be prohibited from operation within the property covenanted herein.
- Except as amended herein, the Declaration, any amendments thereto and all Supplemental Declarations shall remain in full force and effect and shall be unaffected by this Amendment.
